






The Ibeto Group commenced business in the cement sector in 1997 with the importation of ship-loads of bagged Portland cement through the Apapa ports. It is in Bundu Ama, Port Harcourt, Rivers State. It started producing bagged cement at its Bagging Terminal in Port Harcourt in June 2005. The Terminal is an ultra-modern bagging plant with a Flat-storage capacity of 50,000 metric tons and a production capacity of 1,500,000 tons per annum which translates to a production capacity of not less than 6,000 metric tons per day. The Ibeto Group is on the way to establishing a 5-million-tons-per-anum (TPA) or 12,000 Tons per Day (TPD) at Nkalagu, Ebonyi State of Nigeria.

Ibeto Petrochemical Industries Limited

The company was established in 1996 and licensed by the Department of Petroleum Resources to undertake the blending of oil lubricants and the production of various types of SON professionally-certified petroleum products for local and international markets. The Blending Plant is located at Nnewi, Anambra State, Nigeria.

Since January 1999, the Company has been delivering its blended lube products to the West, East, and Central African markets. The Company also procures and trades in a range of petroleum products like Base oil (Bright Stock, etc.) and Automotive Gas Oil including the provision of storage services for various petroleum products via her extensive petroleum tank farms located in Lagos, Nigeria.



Max Shipping Services Limited

The company was incorporated as a limited liability company in 2003 and has grown to become a multi-product company whose business includes a custom bonded terminal, marine services, a shipping agency, clearing and forwarding, and general logistics. The terminal is located at 115 Odoh lbeto Road, Bundu Ama, Port Harcourt. The terminal is equipped with contemporary state-of-the-art equipment and facilities designed to effectively handle containerized and non-containerized cargo for various clients.

Cottonwooden Gas Limited

Cottonwooden Gas Limited is an indigenous downstream gas refinery incorporated in 2017. In 2018, the company commenced construction and installation of state-of-the-art gas processing and compression facilities with a production capacity of 20 MMSCF per day, with high-pressure tubular fleets for product distribution to end users.

Cottonwooden Gas Limited is believed to be the first Indigenous Gas processing and compression facility that obtains its feed gas directly from a gas-producing Well within the Eastern region of Nigeria.

Union Auto Manufacturing Limited

This Company was incorporated on 2nd June 1987 and is today the major player in automotive lead-acid battery manufacturing in Nigeria. It is engaged in the complete manufacturing of first-class quality, completely dry-charged Union brand motor and motorcycle batteries of all capacities. It also produces locally, from its lead and aluminum smelting plant, all the lead and aluminum required for its operations. It has the capacity to produce, annually, the following items: 300,000units of lead/acid batteries, 120,000 units of sealed maintenance-free batteries, 5,500tonnes of lead, 500 Tonnes of accessories, and 1,500 Tonnes of friction parts.

The Company has been exporting pure lead and antimonial lead to customers in Europe, Asia, and Africa since 1991
